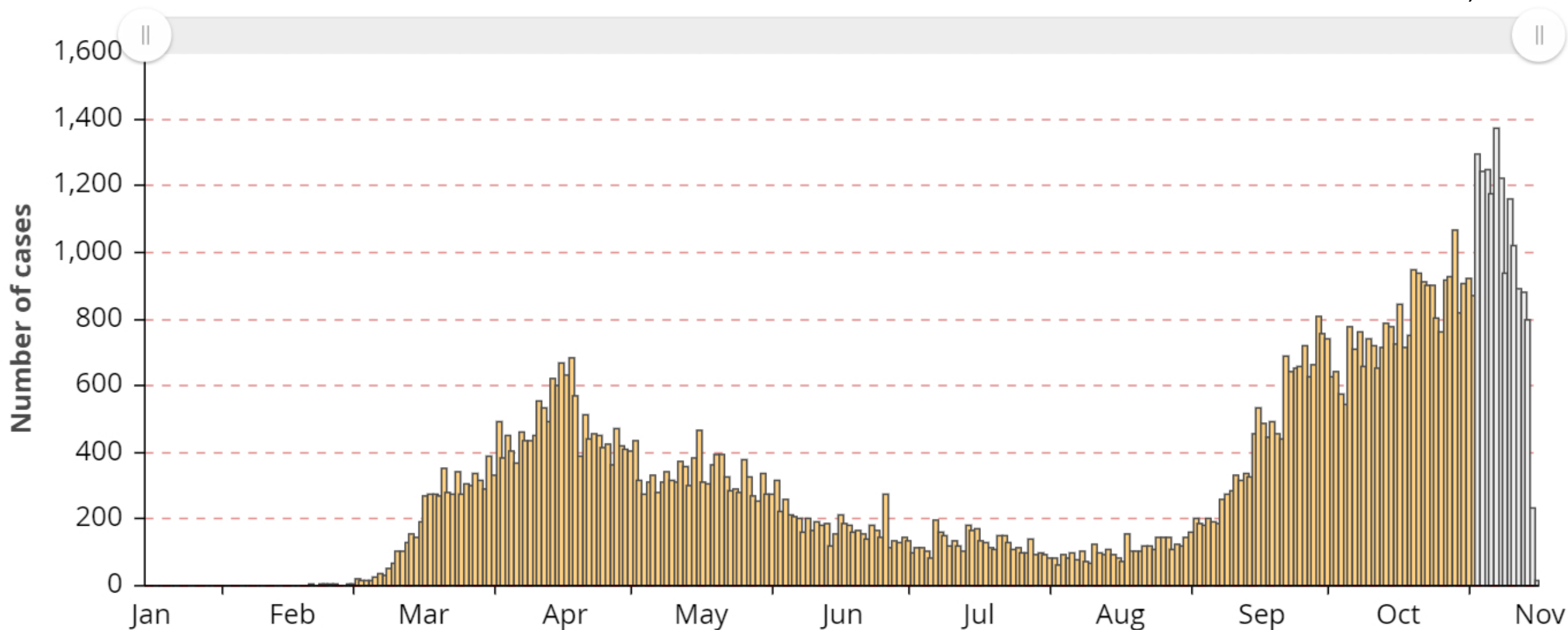

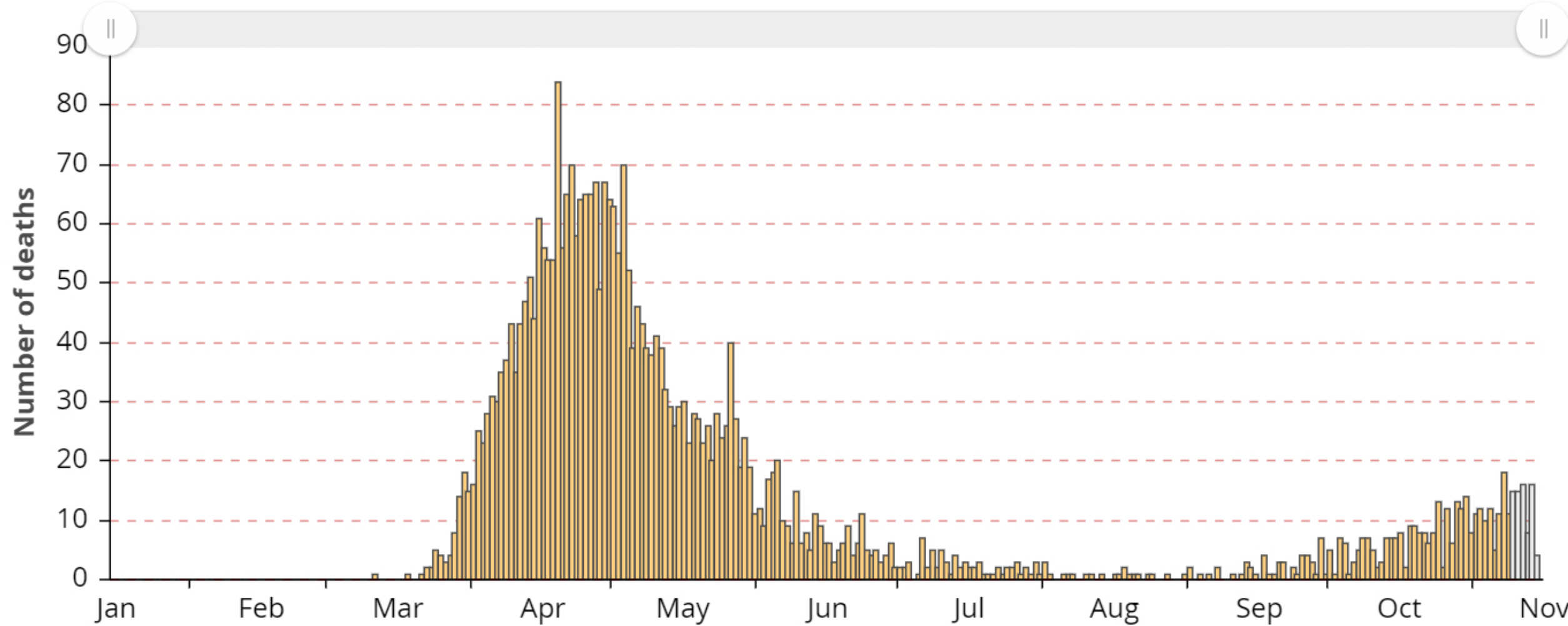
# Count of COVID-19 cases by episode date in Ontario

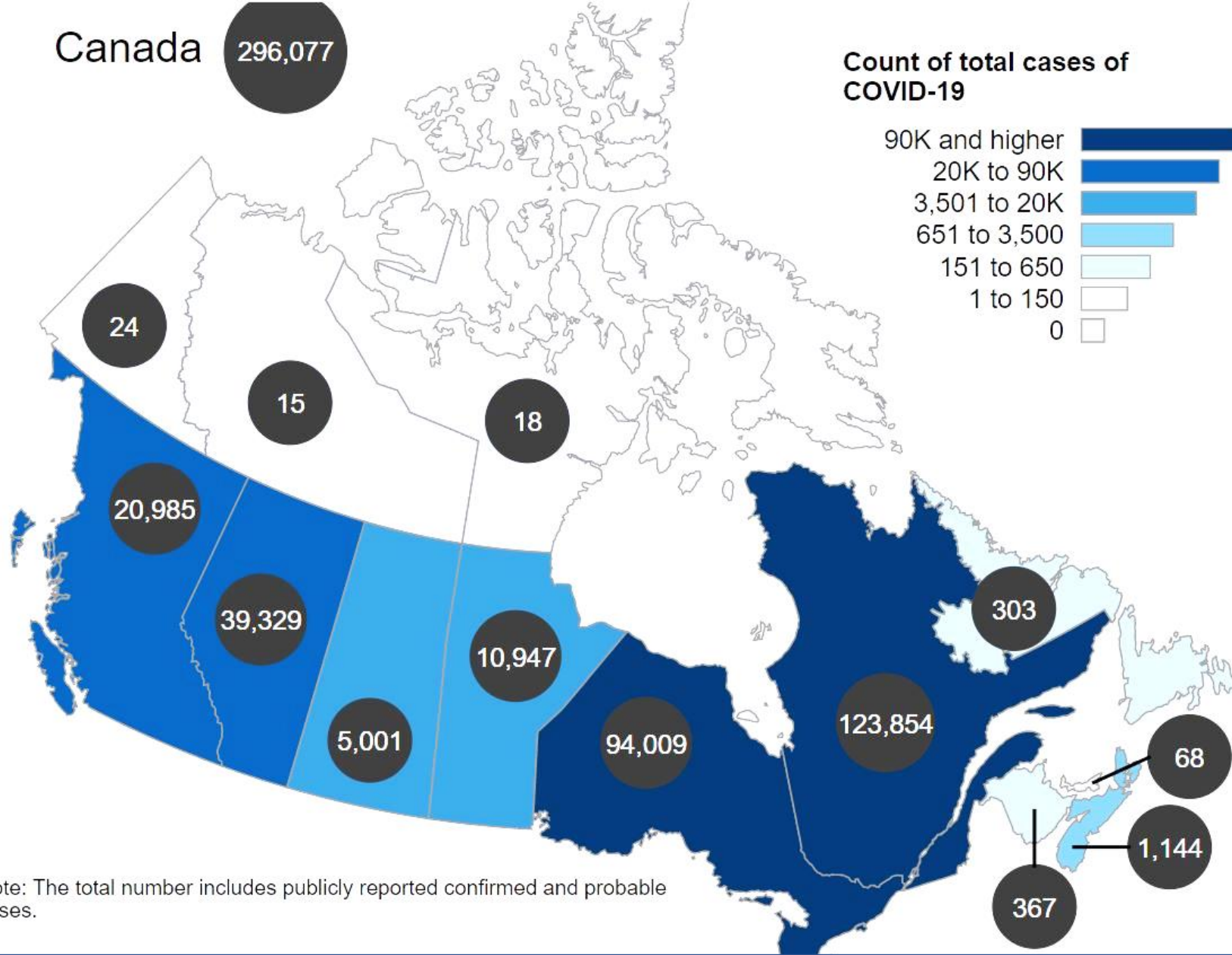

# Count of COVID-19 deaths in Ontario

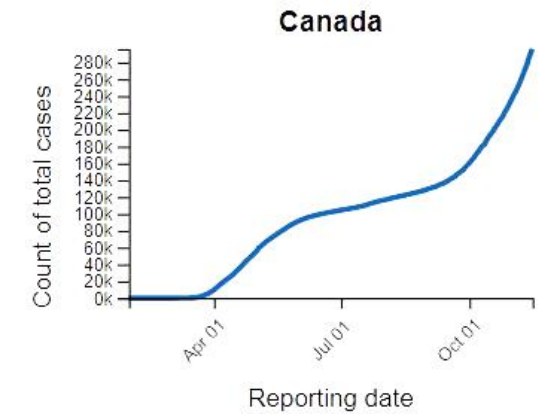

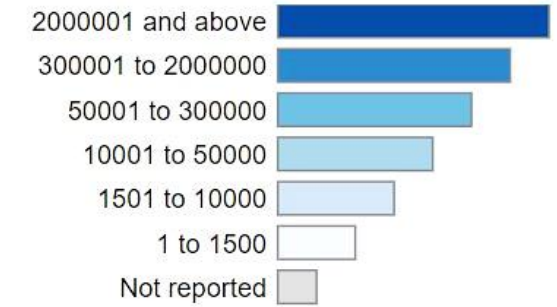

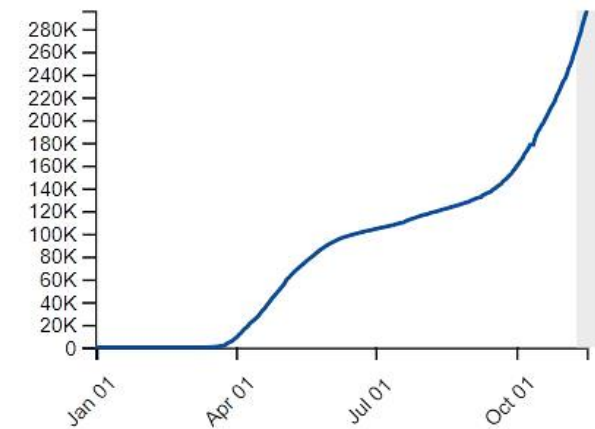

Tactics	Focus on education and awareness of public health and workplace safety measures in place.	Enhanced targeted enforcement, fines, and enhanced education to limit further transmission. - Remember: Things can go wrong
  - ❖ **Newfoundland banned funerals** during the first wave after an outbreak at one funeral home - 143 known cases traced to "the Caul's cluster"
  - ❖ **The stockpiling of bodies** in the US (New York), Italy, Spain, and Quebec
  - ❖ **EL Paso**, Texas, is currently in serious trouble

- BAO will be strictly enforcing the pandemic measures.

# Licensee fee waiver

- ❖ As you know - Licence renewal fees for all BAO licensees are being waived thanks to funding from the provincial government
- ❖ Fees waived for routine licence renewals  
-- due between April 1, 2020 and March 31, 2021

## Please note that –

- ❖ The BAO's licence renewal portal is being adjusted to accommodate the fee waiver for this renewal period
- ❖ Until further notice, do not use the portal and do not to pay your licence renewal fees
- ❖ We expect that our database portal will be operating in first week of December or sooner

## Licensure reporting still required

- ❖ Licensees will still be required to do annual licensure reporting to the BAO, but without paying the licence renewal fees.
- ❖ Annual reports and renewal applications must be received complete and on time, by the due date for each licence class.
- ❖ **Licensees who do not submit these documents by the due date will not be eligible** to receive the fee waiver and full fees will be due.
- ❖ The BAO will issue a refund to licensees who have already paid all or part of their licence renewal fees

## Eligibility

The fee waiver applies to renewals of existing licences only. A licensee applying for renewal must have had a valid licence in 2020.

The fee waiver does not apply to:

1. First-time or new applicants for any licence class;
2. Students who haven't yet passed their licence exam; and
3. Bereavement sector staff who are not licensed by the BAO.
