As a licensed operator, what does this mean for me?

The chart below will help you understand how to calculate your renewal application fee for your operator renewal coming due.

Funeral Establishment (FE) and Transfer Service (TS) Operators:

All FE and TS operators must submit their Annual Licensure Report (ALR) by Dec. 31st of each year. For ALRs which will be due by Dec. 31, 2022, the renewal fee will be based the new fee schedule:

Cemetery (CEM), Crematorium (CREM) and Alternative Disposition (Hydrolysis) (AH) Operators:

All CEM, CREM and AH Operators must submit their Annual Licensure Report (ALR) within 90 days after their fiscal year end (FYE). For ALRs which will be due in 2023, the renewal fee will be based the new fee schedule:
