In accordance with the Funeral, Burial and Cremation Services Act, 2002 and its regulations Ontario Regulation 30/11

Report on Care & Maintenance Fund/Account (Form 2) – Form 2: Cemetery operators who have established a Care & Maintenance (C&M) fund, must submit this report within three (3) months after your fiscal year end.

Exception: If your total C&M funds exceed \$500,000 or you operate a funeral establishment on one or more of your cemeteries, you are required to submit an audit report for the C&M Fund within six (6) months of your fiscal year end.

Report on Prepaid Funds (RPF): All Funeral Establishment Operators – Class 1 & 2, and all Transfer Service Operators – Class 1 & 2 must submit this report within three (3) months after your fiscal year end. All Cemetery, Crematorium and Alternative Disposition (Hydrolysis) Operators that accept prepaids must submit this report within three (3) months after your fiscal year end.

Exception: The reporting requirement does not apply to a pooled trust fund where the amount held in trust did not exceed \$100,000 at any time during the reporting year.

Review Engagement Report: You must submit this report within three (3) months after your fiscal year end.

Exception: If you submit an audit report instead of a Review Engagement for the Prepaid Fund, you must submit the audit within six (6) months of your fiscal year end.

Financial Institution Statements: You must submit financial institution statements pertaining to all funds in trust along with the Report on Care & Maintenance or Report on Prepaid Funds.

Failure to file: Failing to submit the above requirements is a legal offence and the Registrar has the authority to enforce the Act.

Enforcement actions can include:

- Revocation or suspension of your establishment licence.
- Freeze orders on any money or asset of a licensee.
- Charges under the Act and Provincial Offences Act
